Welcome and Introductions

Chairman Arlen Wittrock called the meeting to order at 2:04 p.m.

Chairman Wittrock welcomed Mike Reynoldson, the newest member representing Region III, and introduced him to the council. Mike is employed by Blue Cross of Idaho as their director of governmental affairs.

Council Vote on Approval of Minutes:

Chairman Wittrock noted that the minutes for the July 28, 2016 Economic Advisory Council (EAC) meeting had been distributed and if there are no corrections he would entertain a motion to approve the minutes as distributed.

Chairman Wittrock announced the Council will review the details of two applications for refundable tax credit under the Idaho Reimbursement Incentive Act that have been received by the Director and submitted to this Council for review. The applications contain records and information exempt from public disclosure under Idaho Code §§ 9-340D(6) and 67-4708. Chairman Wittrock entertained a motion under Idaho Code § 67-2345(1)(d) to go into executive session to review the applications.

Review of Tax Reimbursement Incentive for PROJECT V-VALLEY

Chairman Wittrock entertained a motion for PROJECT V-VALLEY.

Motion:

In the matter of the application for PROJECT V-VALLEY, I move that the Council approve the application <u>and</u> instruct the Director to enter into an agreement with PROJECT V-VALLEY upon the following terms:

- A post-performance refundable tax credit which represents 10% of new state revenue for 5 years.
- Tax credit certificate issued post-performance upon review and verification by Commerce.
- No less than 20 new jobs, or 60% of the total annual projected new jobs, whichever is greater.
- Average annual wages must equal or exceed the county average wage of \$40,241.
- Company must maintain operations in Idaho for the term of the agreement.
- Any additional terms deemed necessary by the Director not otherwise conflicting with the above conditions, including allowance for a maximum two-year construction phase during the term of the agreement, as applicable.

The motion was made by Steve Meyer. No second.

Steve Meyer withdrew the motion.

In the matter of the application for PROJECT V-VALLEY, I move that the Council reject the application.

The meeting in October will cover the following topics: legislative updates, Community Development Block Grants (CDBG) and their potential role in providing broadband to Idaho's rural communities, and a discussion concerning Tax Reimbursement Incentives (TRI) and competing companies within Idaho.

Commerce submitted proposed TRI legislation and it remains to be seen whether or not the legislation will move forward.

The lawsuit is continuing as Commerce's motion to dismiss was appealed. The case will go to the Idaho Supreme Court and will be heard in 2017.
