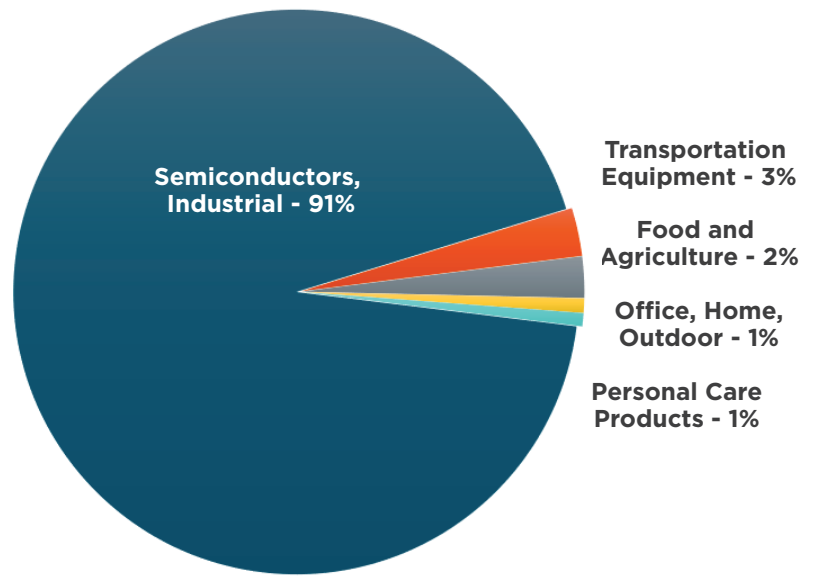




## 2018 TRADE OVERVIEW

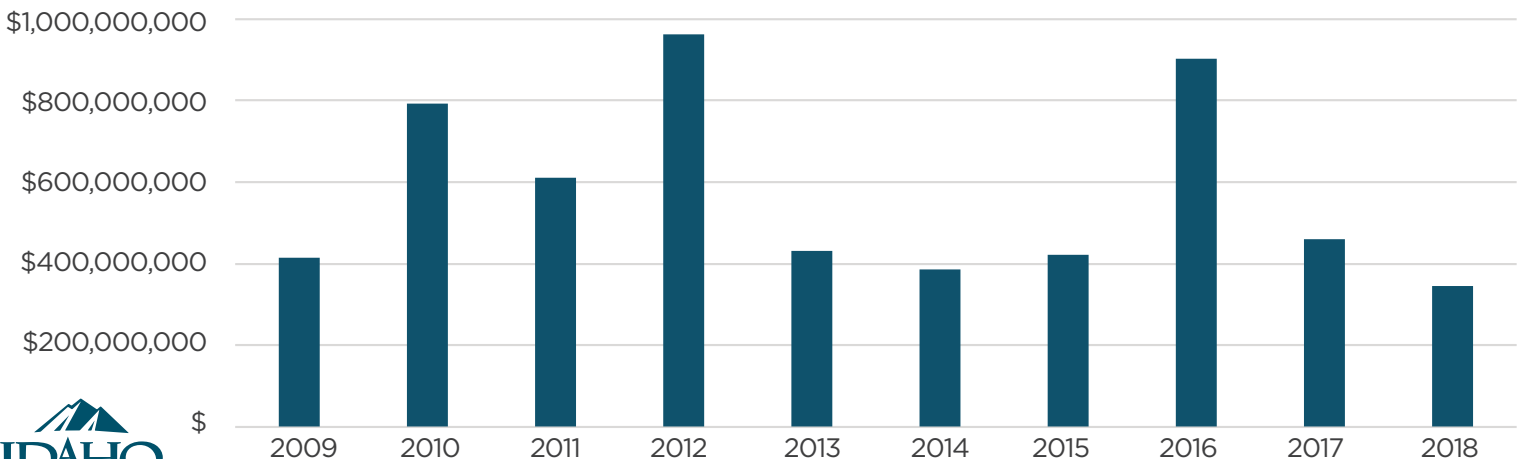
Trade between Idaho companies and Singapore has varied widely over the past 10 years, influenced most by large capital purchases of aircraft, military equipment and technology. In 2018, Idaho exports to Singapore decreased by nearly 25% from 2017.

Technology exports of memory increased, however exports of processors and controllers, as well as integrated circuits, decreased significantly. Exports of solid-state storage devices also decreased significantly in 2018.



Exports totalling < \$2.5M not displayed include mining products; fabricated metal products; wood, paper, pulp and printing; fertilizer, pesticide and chemicals; textiles; apparel and other.
