#### Call to Order

# **Director's Welcome**

Director Kealey updated EAC on the Governors press release indicating that Idaho is opening up phase three this week. COVID-19 is still a serious issue but there are great practices going

on to stop the spread. Commerce has been active on many different fronts to work around the restrictions COVID-19 has placed on us.

#### **Motion to Move to Executive Session**

In the matter of the application for project pure, I move that the Council approve the application and instruct the Director to enter into an agreement with project pure upon the following terms:

- A post-performance refundable tax credit which represents 17% of new state revenue for 8 years.
- Tax credit certificate issued post-performance upon review and verification by Commerce.
- No less than 50 new jobs, or 60% of the total annual projected new jobs, whichever is greater.
- Average annual wages must equal or exceed the average Canyon County wage of \$35,809.
- Company must maintain the minimum required jobs for the term of the incentive agreement.

- Company must maintain operations in Idaho for the term of the agreement.
- Any additional terms deemed necessary by the Director not otherwise conflicting with the above conditions.

- A post-performance refundable tax credit which represents 23% of new state revenue for 12 years.
- Tax credit certificate issued post-performance upon review and verification by Commerce.
- No less than 50 new jobs, or 60% of the total annual projected new jobs, whichever is greater.
- Average annual wages must equal or exceed the average Bannock County wage of \$35,773.
- Company must maintain the minimum required jobs for the term of the incentive agreement.
- Company must maintain operations in Idaho for the term of the agreement.
- Any additional terms deemed necessary by the Director not otherwise conflicting with the above conditions.

- A post-performance refundable tax credit which represents 23% of new state revenue for 11 years.
- Tax credit certificate issued post-performance upon review and verification by Commerce.
- No less than 50 new jobs, or 60% of the total annual projected new jobs, whichever is greater.
- Average annual wages must equal or exceed the average Ada County wage of \$48,492.
- Company must maintain the minimum required jobs for the term of the incentive agreement.
- Company must maintain operations in Idaho for the term of the agreement.
- Any additional terms deemed necessary by the Director not otherwise conflicting with the above conditions.
