## #3612: UI – Optimizing Manufacturing of High Value Components Using Direct Metal Laser Melting Techniques under Reduced Atmospheric Conditions for Industrial Sectors

Dr. Indrajit Charit (University of Idaho) and Mark Jaster, industry partner from Premier Technology Inc., are requesting **\$274,167.00** for research and development in optimizing laser metal deposition additive manufacturing techniques.

# #3637: BSU – RNA-Based Testing: Rapid STD Detection, Patient Compliance and Response Monitoring

Dr. Greg Hampikian (Boise State University) and Steve Verschoor from Molecular Testing Labs are requesting **\$255,496.00** (modified amount from original submission) for research efforts to commercialize a ribonucleic acid (RNA) home test for early HIV detection.

# Funding Consideration:

The IGEM program balance is currently at \$462,935. Idaho Commerce also has \$69,522 available to supplement the program balance, should the IGEM Council want to fund both projects.

# Action Item: #3612 - Optimizing Manufacturing of High Value Components Using Direct Metal Laser Melting Techniques under Reduced Atmospheric Conditions for Industrial Sectors

The Council discussed this project. Dr. Hill did visit the Idaho National Lab in regards to this project.
