The project will build off of a fiber optic line placed to serve Joint School District 171 in 2019. The fiber was laid along City, County, Highway District and State roadways from Orofino to Timberline School and into Pierce. the mainline fiber was part of the Joint School district E Rate fiber to schools construction project; its purpose is to connect the schools.

The current communications infrastructure serving parts of the Proposed Service Area (PSA) is very old copper. In parts of the PSA (Cascade Drive) no wired infrastructure is in place and fixed wireless options are non-existent. The very low density and very high-cost infrastructure deployment in this very rural area of the county has been a challenge. CARES Act funding paired with the existing E-Rate built backbone offers this project economic feasibility. This fiber to the premise project will provide the ability for residents to access the internet at speeds capable of teleworking, remote learning, accessing telemedicine and simply accessing the vast informational resources and entertainment provided today across the World Wide Web. Youth

living in the PSA will gain access to the world through the enhanced connectivity Fatbeam will offer.

The proposed project to deploy a fiber to the premise capable network meets the CARES Act criteria by:

Being a broadband infrastructure (wireline) investment; Through enabling connectivity at speeds up to 1/1Gbps; Facilitating greatly enhanced access to telework, telemedicine, distance learning and public safety; and, providing service in a currently unserved area.

A fiber optic deployment across the PSA will offer future proof connectivity.

The project will activate an existing fiber cable infrastructure, previously constructed to serve the needs of JSD171 for interfacility connection from Pierce to Orofino. With the mainline trenching work done the private sector provider return on investment is more reasonable. The project scope of work is focused on the Point of Precense, and electronics required to light the fiber backhaul thus enabling to the premise services. This project will provide a cost effective deployment of a future proof network to rural Clearwater County. The PSA traverses some of the least populated area of Clearwater County which, to date, has been deemed very high cost. Funding from the Idaho CARES Act will offset the extreme high cost for deployment of a fiber to the premise location and offer rural Clearwater County residents internet connectivity options comparable to the most urban places.

#### History

In 2003 at the regional Think Like a Region Economic Development Summit the lack of broadband access was deemed the regions' highest concern for community sustainability.

In 2006 Orofino convinced Verizon a fiber backhaul was needed to replace the microwave link that provided all communications within Clearwater County. A 46 strand fiber cable was run from Moscow to Orofino and on up to Weippe.

In 2007, the Clearwater Library District leveraged Idaho Commerce & Labor broadband finds with Gates Foundation funding to work with First Step Internet to build fixed wireless to Weippe. The Elk River Free Library District was awarded USDA Community Connect funds to become the ISP and deployed a fixed wireless mesh network; with backhaul from First Step Internet Elk River was connected. And, a small private ISP, QRO Internet deployed a fixed wireless network in Pierce with a T1 from Frontier.

In 2010 the Nez Perce Tribe secured American Recovery and Reinvestment Act funds to deploy a Reservation wide fixed wireless network. Clearwater County provided infrastructure (rooftops) and interconnected all county government facilities using the Tribes network.

In 2017 Frontier indicated a plan to run fiber to Pierce to serve the Idaho Youth ChalleNGe Academy (IDYCA). This project never came to fruition.

2019 the Joint School District 171 leveraged E Rate funding to construct a fiber connection from Orofino schools to Timberline k-12 and into Pierce for the IDYCA.

2020 secured ID CARES Act funding to deploy fiber to premise in Orofino, Weippe-Pleasant Acres-SE unincorporated areas; and fixed wireless to Elk River.

Operating an Electrical Contracting business requires a dependable and speedy connection to research products, purchase produces, locate schematics, and information to repair and install products. The Idaho Department of Building Safety Electrical Division requires me to acquire CEU certificates to renew my Journeyman and contractor Licenses. The online training is exceptional. Permits and Licenses renewals with IDBS is accomplished with a reliable web connection. My current connection to the internet is slow at times and fails frequently in the middle of acquiring permits or training.

My wife is a Registered Traveling Nurse for Option Care Health out of Spokane, WA and has to do all her charting and other communication with the Corporation via internet. Having such an unreliable signal strength make is hard to accomplish. There are also many Continuing Education opportunities that are only available online and have timed testing that she has to go to the Weippe Library so that she is not in the middle of a timed (limit of two attempts) to pass test so that her signal is not disrupted during these test and causing her to fail a needed class. She also work for Clearwater Valley Hospital and Clinic and she is required to do CEU for them also that is hard to accomplish with the slow internet speed and interrupted connection.



Historically residents of Idaho County have experienced some of the worst internet in the State of Idaho. Broadband Now had reported that only 3.6% of residents had broadband (2020)

Challenging topography, rural nature, and the fact that Idaho County is the largest geographic county in Idaho (8485 sq miles) have presented serious obstacles that have prevented providers from building out modern broadband infrastructure in a cost effective manner.

In 2020, Idaho County received a State of Idaho Broadband Grant to build-out 22 sites designed to provide coverage to 2,000 homes at an average cost of \$425 per location. This project was extremely successful in that 28 total sites were built out within budget for one of the lowest cost-per-locations among all of the State broadband grants awarded in 2020.

Prior to submission, the 2020 project was trimmed back due to the tight 4-month timeline allowed for completion. Key areas that were trimmed back prior to submission include the areas detailed in this grant application. These areas include the often forgotten and overlooked areas since they are on the extremities and farther out from population centers. These are the areas that will never have broadband infrastructure built out save for a grant due to challenging ROI.

This broadband project for 2021 is designed to expand upon what was accomplished in 2020

and to reach further out into rural Idaho County, and to finally provide broadband access to a number of forgotten and overlooked areas.

This project will provide coverage to 600 homes for an average cost of \$833 per location covered. It should be noted that the increase in cost-per-location from \$425 to \$833 can be accounted for due to increases in construction costs in 2021, and more importantly, the increasing difficulty of reaching homes and businesses that are not economically feasible for ISPs to provide service. This is due to the fact that any given site in a remote area will serve a fraction of the homes as a site in a populated area will, yet they will still cost the same to build out. Dividing a \$40,000 site by 100 covered homes gives you roughly \$400 hard costs per home.

It should be noted that this project offers the following advantages:

Extendibility: infrastructure put into place in 2021 will be utilized to continue expanding out even further in future years

Upgradability: sites built out in 2021 can be upgraded in the future to offer ever faster speeds as new technology emerges

ISPs in the region that can provide fixed wireless service include AirBridge Broadband, First Step Internet, and Inland Cellular. The County published request for proposals for ISP (twice in the Idaho Free Press) to build, deliver and own this project. RFPs were due on 7/14 and the County received one proposal from AirBridge.

Satellite is currently the only option for a number of the homes that this project will cover.

Having satellite as the only option is by definition inadequate and has serious negative impacts on the community as satellite is neither cost effective nor does it adequately support video conferencing - which is necessary for telehealth, education, public safety, or economic development.

The broadband provider for this project will promote equal access to promote economic development, public safety, telehealth, education for the following reasons:

(1) cost per account is the same whether a business or a home (businesses are not charged more just because they are a business)

(2) free internet will be provided for all first responder facilities, fire departments, community centers

(3) provider does not differentiate or discriminate, but installs all locations as quickly as possible and in the order in which they are requested

This project brings real broadband internet (up to 100 Mbps / 20 Mbps with no data caps) to homes and businesses that do not currently have access to the bare minimum internet.

This project will enable telehealth, education, public safety, and economic development both

now and into the future as new technology emerges and the sites are correspondingly upgraded.

In the past, most of these rural communities were overlooked due to the time and expense of putting in the necessary infrastructure to serve them. It simply is not cost effective to do a \$500,000 build-out (traditional cell phone tower) to serve only 100 homes. Fiber to the home would be ideal and most desirable, but is not feasible given topography, costs and easements/ROW, especially given the timeframe of the project deliverable. This lack of investment in broadband infrastructure has had a negative impact on Idaho County economically, but these shortcomings have become even more apparent in light of COVID-19 as residents do not have access to broadband capabilities that enable social distancing, telework, and distance learning. This project meets the broadest level of need for a feasible price in the timeframe required.

Historically residents of Lewis County have experienced some of the worst internet in the State of Idaho. Broadband Now had reported that 21.5% of the residents had broadband (2020)

Challenging topography coupled with the fact that Lewis County is one of the least populated counties in the State of Idaho have presented serious obstacles that have prevented providers from building out modern broadband infrastructure in a cost effective manner. Lewis County is also a very fiscally challenged county, with a diminishing tax based competing with demand for services.

In 2020, Lewis County received a State of Idaho Broadband Grant to build-out 16 sites designed to provide coverage to 1,000 homes at an average cost of \$470 per location. This project was extremely successful in that all 16 sites were built out within budget for one of the lowest cost-per-locations among all of the State broadband grants awarded in 2020.

Prior to submission, the 2020 project was trimmed back due to the tight 4-month timeline allowed for completion. Key areas that were trimmed back prior to submission include the areas detailed in this grant application. These areas include the often forgotten and overlooked areas since they are on the extremities and farther out from population centers. These are the areas that will never have broadband infrastructure built out save for a grant due to challenging ROI.

This broadband project for 2021 is designed to expand upon what was accomplished in 2020 and to reach further out into rural Lewis County, and to finally provide broadband access to a number of forgotten and overlooked areas. According to the broadbandusa.maps.arcgis.com website, the median speedtest in the Census Tract where this project will take place is only 10.80/2.37 Mbps.

This project will provide coverage to 220 homes for an average cost of \$909 per location covered. It should be noted that the increase in cost-per-location from \$425 to \$909 can be accounted for due to increases in construction costs in 2021, and more importantly, the increasing difficulty of reaching homes and businesses that are not economically feasible for ISPs to provider service. This is due to the fact that any given site in a remote area will serve a fraction of the homes as a site in a populated area will, yet they will still cost the same to build out. Dividing a \$40,000 site by 100 covered homes gives you roughly \$400 hard costs per home.

It should be noted that this project offers the following advantages:

Extendibility: infrastructure put into place in 2021 will be utilized to continue expanding out even further in future years

Upgradability: sites built out in 2021 can be upgraded in the future to offer ever faster speeds as new technology emerges

ISPs in the region that can provide fixed wireless coverage include AirBridge Broadband, First Step Internet, and Inland Cellular. The County published a request for proposal twice (in the Lewis County Herald) for ISPs to build, deploy and own the project. Only AirBridge submitted a proposal and was selected by the Commission at its 7/14 meeting

Satellite is currently the only option for a number of the homes that this project will cover.

Satellite as the only option is by definition inadequate and has serious negative impacts on the community as satellite is neither cost effective nor does it adequately support video conferencing, which is necessary for telehealth, education, public safety, or economic development.

The broadband provider for this project will promote equal access to promote economic development, public safety, telehealth, education:

(1) cost per account is the same whether a business or a home (businesses are not charged more just because they are a business)

(2) free internet will be provided for all first responder facilities, fire departments, community centers

In the past, most of these rural communities were overlooked due to the time and expense of putting in the necessary infrastructure to serve them. It simply is not cost effective to do a \$500,000 build-out (traditional cell phone tower) to service only 100 homes. Fiber to the home would be ideal and most desirable, but is not feasible given topography, costs and easements/ROW, especially given the timeframe of the project deliverable. This lack of investment in broadband infrastructure has had a negative impact on Idaho County economically, but these shortcomings have become even more apparent in light of COVID-19 as residents do not have access to broadband capabilities that enable social distancing, telework, and distance learning. This project meets the broadest level of need for a feasible price in the timeframe required.

Our proposal will provide 220 County households, currently unserved or underserved, access to affordable fixed wireless broadband service that will meet or exceed the FCC recommended speed of 25/3 Mbps with speeds up to 100 / 20 Mbps.

Historically residents in and around Culdesac have experienced some of the worst internet in the State of Idaho.

Challenging topography and the rural nature of Culdesac and surrounding areas have presented serious obstacles that have prevented providers from building out modern broadband infrastructure in a cost effective manner.

Although infrastructure investments have been made in the more urban areas of Nez Perce County, Culdesac is often overlooked and forgotten.

After seeing the success that Idaho and Lewis Counties had with broadband expansion in a cost effective manner via the 2020 State Broadband Grants (under \$500 per location), it was better understood that Culdesac and surrounding homes could also have broadband infrastructure built-out in a cost effective manner.

This project will build out approximately 5 sites at a total cost of \$300,000. It will provide speeds up to 100 Mbps / 20 Mpbs to around 340 homes at an average cost per location of \$882.

This project offers the following advantages:

Extendibility: infrastructure put into place in 2021 will be utilized to continue expanding out even further in future years

Upgradability: sites built out in 2021 can be upgraded in the future to offer ever faster speeds as new technology emerges

ISPs in the region providing fixed wireless include AirBridge Broadband, First Step Internet, Inland Cellular, and the Nez Perce Tribe. The City completed an RFP process for an ISP, publishing a legal notice twice in the Lewiston Morning Tribune, and selected AirBridge at its July 12 council meeting.

Since this project will target a number of forgotten and overlooked areas of Nez Perce County, where real investment is modern broadband infrastructure has proven to be elusive, residents will finally be able to have access to video conferencing capabilities, which is necessary for telehealth, education, public safety, and economic development.

The broadband provider for this project will promote equal access to promote economic development, public safety, telehealth, education for the following reasons:

(1) cost per account is the same whether a business or a home (businesses are not charged more just because they are a business)

(2) free internet will be provided for all first responder facilities, fire departments, community centers, city hall

(3) provider does not differentiate or discriminate, but installs all locations as quickly as possible and in the order in which they are requested

In the past, most of the rural communities were overlooked due to the time and expense of putting in the necessary infrastructure to serve them. It simply is not cost effective to do a \$500,000 build-out (traditional cell phone tower) to service only 100 homes. Fiber to the home would be ideal and most desirable, but is not feasible given topography, costs and easements/ROW, especially given the timeframe of the project deliverable. This lack of investment in broadband infrastructure has had a negative impact on Culdesac economically, but these shortcomings have become even more apparent in light of COVID-19 as residents do not have access to broadband capabilities that enable social distancing, telework, and distance learning. This project meets the broadest level of need for a feasible price in the timeframe required.

#### History

In 2003 at the regional Think Like a Region Economic Development Summit the lack of broadband access was deemed the regions' highest concern for community sustainability.

In 2006 Orofino convinced Verizon a fiber backhaul was needed to replace the microwave link that provided all communications within Clearwater County. A 46 strand fiber cable was run from Moscow to Orofino and on up to Weippe.

In 2007, the Clearwater Library District leveraged Idaho Commerce & Labor broadband finds with Gates Foundation funding to work with First Step Internet to build fixed wireless to Weippe. The Elk River Free Library District was awarded USDA Community Connect funds to become the ISP and deployed a fixed wireless mesh network; with backhaul from First Step Internet Elk River was connected. And, a small private ISP, QRO Internet deployed a fixed wireless network in Pierce with a T1 from Frontier.

In 2010 the Nez Perce Tribe secured American Recovery and Reinvestment Act funds to deploy a Reservation wide fixed wireless network. Clearwater County provided infrastructure (rooftops) and interconnected all county government facilities using the Tribes network.

In 2017 Frontier indicated a plan to run fiber to Pierce to serve the Idaho Youth ChalleNGe Academy (IDYCA). This project never came to fruition.

2019 the Joint School District 171 leveraged E Rate funding to construct a fiber connection from Orofino schools to Timberline k-12 and into Pierce for the IDYCA.







The Genesee Joint School District 282 and the Kendrick Joint School District 283 employ three essential, public employees that live along Jones Road (census block 160570057003001 and 1605700570003041) nine miles equidistant between the communities of Genesee and Juliaetta, Idaho in rural Latah County. One employee is Kendrick School District's technology director. The other two employees are certified educators that each work for one of the two school districts. Their ability to communicate from home to students and district personnel are critical to distance learning.

Ziply Fiber, an internet service provider (ISP), has a fiber line that runs along the Genesee-Juliaetta Road; but, the residents along the road are not connected to it. The only accessible broadband is satellite and service that does not provide dependable service of speeds of 25 Mbps download and 3 Mbps upload.

The project scope of work includes the installation of approximately one mile of fiber and connecting equipment to four households.

Scope of Work:

- (1) Placement of a handhole at Jones Road and Genesee-Juliaetta Road
- (2) Place a hub with remote cascaded splitter
- (3) Placement of distribution fiber to homes along the route (10,000 feet)
- (4) Placement of a service fiber drop to homes

Once the fiber is installed and the system is operational, ISPs that could provide the proposed service include any and all that service the area, such as Inland Networks, TDS, First Step, Ziply, etc. However, because Ziply owns the fiber along the Genesee-Juliaetta Road, they can restrict any other service provider from building out and providing service on Jones Rd.

For six years, residents have actively searched for a solution to their broadband needs. With the impact of COVID-19 on the school districts, it is imperative that this weakness in broadband capacity be addressed.

Even in 'normal' times, staff are expected to have connectivity at home in order to fully execute their job responsibilities. Specifically, our Technology Director is asked to monitor and troubleshoot technology issues that are occurring in the school district 24 hours a day. The school district regularly faces technology issued during 'off' hours where time can be critical.

With the pandemic, both school districts have been offering online courses and expect to continue this method of educational delivery. It is nearly impossible for these three school employees to assist students and district personnel from their homes... If funded, this project will provide critical infrastructure and broadband services to not only employees of the district but also to students.

It is currently impossible to give educational access equity for learning to Kendrick and Genesee students living in this unincorporated community compared to other areas of Latah County, and it is impossible for public employees to perform their essential job duties from home without terrestrial broadband. The ability for multiple students and critical school district staff to have this capacity is hindered only by the the cost and funds necessary to bring fiber to these households.

Latah County will solicit bids from ISPs through an RFP process. This project directly serves a non-incorporated community of homes that are located along Jones Road between Genesee and Kendrick, Idaho. My husband and I have been grateful to be a part of that community for the past seven years. In those seven years we've had two telecommunication system provider options. Both of these options are satellite internet only providers that have proven to be very costly (\$90-\$110/month for internet only/no bundle), unreliable (internet fails during peak hours), and slow (speeds that are marketed at 5 mbps are actually 500 kbps-1 mbps).

I've directly researched and spoken with all local internet providers and no provider can provide us with service other than these satellite options. I've inquired to the Latah County Commissioner liaison for the State of Idaho Federal Communication Commission (FCC) about supporting a grant application for our part of rural Idaho and was told that one internet provider indicates that they can serve all of Latah County adequately and until this claim is accurately reported to the FCC that we may never get supported for a grant application. I've also directly spoken to the nearest owner of a fiber system that is less than ¼ mile away to see if there could be any drops made in that system and received feedback that a secondary conduit was not installed during trenching efforts from Genesee to Orofino and that the primary fiber line cannot be spliced for a residential drop. I'm sincerely hoping this effort is successful considering the wind has left my sails a few times during these efforts over the last 7 years.

Reliable internet is critical to my family for our ability to work from home, especially during the COVID-19 pandemic. I am the Area Manager for J-U-B Engineers, Inc. Clarkston, Washington office and a civil engineer managing transportation projects. My ability to communicate with my staff of nine employees as well as additional communication with our 17 offices is critical to my job. I have two young sons. The Nez Perce Tribe has prioritized broadband deployment and understands how critical infrastructure is to all aspects of education, health and welfare. While the Tribe has been able to deploy the existing network over many years adding communities and services as we expand, rural last mile fiber continues to limit capacity and deployment. Communities throughout Idaho are not concentrated in a central town or community but are sprawling beyond city limits which makes the last mile fiber deployment just out of reach for most residents and service provider.

This project will expand upon the Idaho Broadband grant completed with State funding earlier this year. The focus on the last State Grant was to deploy the middle mile connectivity to reach housing clusters. This grant will connect the sprawling homes along the middle mile that were not connected due to single run costs to individual homes. Work and school from home continue to be a significant demand and the ability to provide emergency response and health care connectivity.

Thunder Hill Road outside of the Lapwai area contains approximately 46 homes. The fiber runs the road length from Lapwai to Spaulding. Along that road are farms and residents with school

age children. For some of these homes, the only service available to them is satellite because of the hillsides there is no line of sight for wireless internet. This project will add four fiber sheds along the path with home connection to each resident.

While we were constructing the middle mile residents along the road were excited and eager to adopt service. One of these homes has medical equipment and daily automated medical equipment reporting for a household member. Currently these readings are automated and are conducted over what can only be called dialup service. The medical center calls at a specific time each day, the resident connects the live call to the medical equipment and transmission begins. Adjustments to medical care are made based on these calls. If they had broadband these medical readings could be done real time adjusting more frequently to meet the patient needs.

Nez Perce Network Systems is an authorized Emergency Broadband Benefit service provider. Residents that qualify for EBB can selected the Tribe as their provider and get subsidized residential service. Prior to EBB, during the first shelter is place mandates, the Tribe determined that they would not terminate or disconnect residential service due to nonpayment. The Tribe is committed to ensuring broadband access is available for work/school from home and telehealth. We've priced our service for our rural residents and have not based our rates on some national return on investment pricing metrics like the major telecom providers.
