With just over 550 citizens, Weston is a remote, rural community with little access to reliable broadband services. This project will bring fiber broadband capabilities directly to the homes in the city of Weston; making telehealth, remote working and distance learning a reality for the people of Weston. Direct Communications is the only ISP in the area with the backbone infrastructure. They serve the cities of Oxford, Clifton, Dayton and Preston. Other ISPs are available through satellite service, but not with the capacity or reliability of fiber. Direct Communications intends to run over 81,000 feet of fiber, which they have contributed to the project, and bring the service to 154 homes in Weston.

Question: Explain how the project will promote equal access in economic development, public safety, telehealth, education, including why current infrastructure is inadequate or negatively impacts the community?

Weston doesn't have reliable internet service to facilitate remote learning, working from home or even telehealth capabilities. During the COVID-19 pandemic, it was impossible for families with multiple remote learners to adequately access school work for their children; let alone access needed service to work from home at the same time. Weston is an aged community. Individuals on a fixed income cannot afford the exorbitant cost of premium service in their homes to facilitate telehealth visits, allowing them to safely see their medical providers. This project will bring a reliable, cost effective broadband option to their front door. Current infrastructure is a

large factor in economic development for the area. The cost for a small business to provide e-commerce on a reliable system is too high, excluding Weston as an option for small, local businesses that rely on internet service for success.

The COVID-19 pandemic sent kids home from school, people home from work and kept vulnerable populations isolated from family, friends and without access to needed interactions. Without reliable internet services, children cannot learn, people cannot work from home and large populations of Weston were without the capability to access telehealth for safe interactions with their providers. Access to high speed, affordable fiber will allow for remote learning, telework and facilitate telehealth for the people of Weston. It will also allow vulnerable populations to access services to keep them safely involved in the lives of their friends and families; making isolation a little more tolerable and keeping seniors safe.

This project is a fiber to fiber to the premises build that will bring fiber directly to consumer and negating the need to pay for the infrastructure as an individual. It will also provide reliable services to the community for a third of the current estimates from satellite providers. This will allow the community of Weston to access 50mbps symmetrical, which is Direct Communications basic package for \$59.95 a month, in comparison to other companies that offer 12 mbps X 3 mbps for \$149.99 a month.

Direct Communications will own the fiber in the conduit but the fiber only; which is necessary in order for them to tie the new fiber back to their existing network. Upon funding, the City of Weston and Direct Communications will have a MOU that outlines equal access and choices for the citizens within the impact zone.


I know personally and professionally I would benefit from having Broadband brought to Weston. Please consider awarding Weston with the grant to bring Broadband here.



We are seeking to bring fiber to Nounan, located in Bear Lake County. This unincorporated communities currently has no fixed high speed internet. In today's world, broadband access is critical. According to the Idaho Department of Health and Welfare, "Expanding access to broadband is a high priority for economic developers, especially in rural Idaho. High-speed Internet is a standard part of doing business. A lack of access to the service limits local businesses' ability to expand, find employees, find suppliers, train their workers and market their products."

(https://idahoatwork.com/2020/01/22/governors-task-force-makes-recommendations-to-improve-idal Additionally, the project helps residents work from home during the pandemic and helps students in their schoolwork.

The project will provide fiber to the home for 36 households, and will pull a fiber drop to every rooftop that gives us property access. Even if they do not sign up for service.

We are seeking Direct Communications as our single source provider, as they have fiber in the neighboring community of Bern and can most feasibly provide the connection. They can provide the broadband service, the required technologies and equipment, and the installation and operation of the new broadband service. Below they have created a construction narrative that, we believe, does a nice job of laying scope of work, construction timelines, phases, and required

work:

"Our construction process begins with preliminary route planning. Our engineering group decides the best route to take to get service from our existing plant, to all desired locations in the new build. During this time, we try to identify and avoid major impediments. These would include land managed by the BLM or BOR, wetlands, lands of anthropological significance, and other such considerations. Additionally, during this phase, we identify the permits we will need to obtain to do the work; railroads, ITD, county, and city jurisdictions. After routes are planned and materials procured, we move into the physical construction phase. Utility locates are called in via the 811 Digline request. Depending on right-of-way makeup (sidewalk, gravel, dirt, etc), the method of installation will vary from directional drilling to vibratory plow. These methods will produce anywhere from 400 to 3500 feet of mainline conduit laid per day. While this conduit is being laid, we set hand holes, or junction boxes at intersections, future service locations, and as needed for storage for future needs (additional services, repairs, etc). Once all of the conduit has been installed, and hand holes are set, we have to proof the duct and prepare it for fiber installation. We are able to install 3500 - 20000 feet of mainline fiber in a day. Next, our splicing group creates a light, or data connection back to our point of origin. Running concurrent with drops and splicing, our installation team will be installing service inside the premise. Once the installation and splice are complete, the premise will have service."

The project will provide equal access to ultra rural residents, who may never otherwise have high speed broadband options. There is little likelihood that another provider would ever make the investment to provide broadband to this area, as middle-mile infrastructure in Georgetown belongs to Direct Communications. However, in the interest of equal access, we will require an MOU with the service provider that they will own the fiber must make available circuits and carrier services to competitive providers at fair market rates.

The County is especially concerned to make sure that students have internet access at home. Bear Lake County Schools have a 1 to 1 student to device plan, and nearly all middle and high school work is presented completed on the "Summit" online platform. Students do not use text books, or many traditional materials. This is difficult for students who live in remote areas.

Question: Explain how the project will promote equal access in economic development, public safety, telehealth, education, including why current infrastructure is inadequate or negatively impacts the community?

The project will promote equal access in economic development, public safety, telehealth, education. The county is seeing increasing numbers of homes that were originally built as second homes being converted into full time residences due to more people working from home. Additional full time residents help promote local industry beyond the tourism sector. The Nounan area is also heavily agricultural. Improved internet access helps provide farmers opportunities to explore new markets and helps provide access to services otherwise not available, such as public safety location services, telehealth, and education. This helps to retain the agricultural industry that is the backbone of the local economy. Online schooling has been required during COVID school closures and quarantines.

The area is currently only served by satellite internet service, provided off a solar tower, which can be affected by weather and other factors, making service spotty and unreliable.

Question: Explain how your project meets Cares Act Criteria, is necessary for the public health emergency, and mitigates similar disruptions in the future?

This project will meet CARES Act Criteria by addressing key areas of public health and safety by improving opportunities to telework, improving access to telehealth services, facilitating distance

learning, and improving public safety. Providing fiber internet service meets the criteria by allowing the residents of Nounan access to work and complete school activities from home. Additional residents who contract COVID face long distances to see health providers and telehealth increases residents' access to medical care. COVID has prompted periods of online schooling for all students, as well as quarantines for individual students. Bear Lake County's online "Summit" platform has allowed students to complete much of their work from home, but only if they have reliable internet. These concerns make reliable internet services especially critical for our rural students. First responder's ability to locate calls for services is also improved by internet service.






