### **2017 CAPER (CONSOLIDATED ANNUAL PERFORMANCE EVALUATION REPORT)**

Idaho Department of Commerce is HUD's Grantee for the Idaho's Community Development Block Grant program. Idaho Housing and Finance Association is HUD's Grantee for Idaho's Emergency Solutions Grant Program, the HOME Investment Partnerships (HOME) Program, and the National Housing Trust Fund Program.

The 2017 CAPER is an annual report submitted to HUD for review and approval. The drafting process requires a time for public input. A summary of all public comments will be included in the CAPER.

### **REVISED 2018 ANNUAL ACTION PLAN**

Idaho Housing and Finance Association requests public comment regarding certain revisions made to the current 2018 Annual Action Plan. The revisions are related to the HOME program's 2018 annual allocation. The FY18 HOME allocation will exceed 25% of the average HOME allocation for the previous three years. Whenever an allocation meets this threshold, the public is provided additional time to submit comment. Following this comment period, the Plan will be submitted to HUD.
