



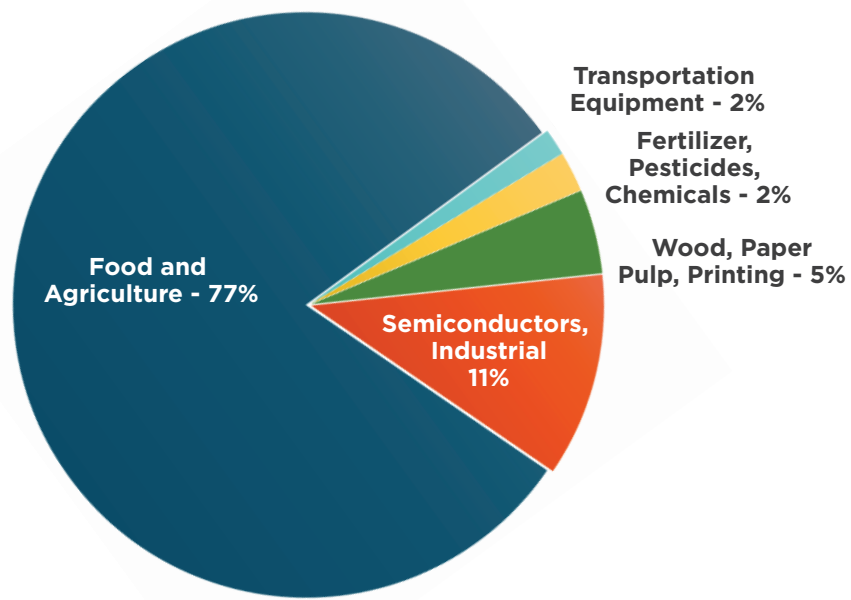
## 2018 TRADE OVERVIEW

Mexico remained Idaho's 5th largest export partner, however, total exports declined 0.59% in 2018.

Uncertainty regarding USMCA may play a causal role in the stagnant export numbers.

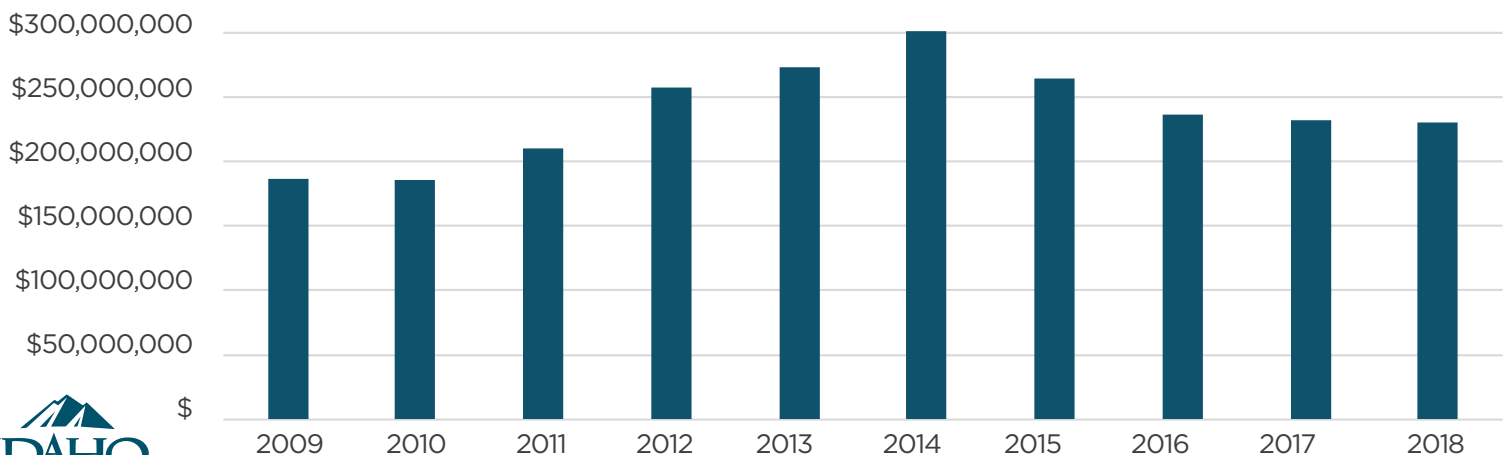
Malt, flour and memory exports decreased most significantly in 2018.

Oil seeds and dairy products showed the most significant growth.
