The City of Buhl is proud to submit this application for an Idaho Community Development Block Grant. We are seeking \$454,800 to help fund improvements to the City's water and sewer systems. Economic Advisory Council

The City of Buhl sits 16 miles east of Twin Falls in south-central Idaho. Known as the "Trout Capital of America", Buhl's success has largely been built on world-famous trout hatcheries and food processing. Over the last ten years, the City has been bringing the community's infrastructure in line with current environmental standards and requirements. The City conducted extensive video and engineering analyses of their municipal water and wastewater systems to determine what sections needed replacement and to create a timeline for these replacements. The results were two massive, mandated infrastructure projects — an \$8.0 million arsenic mitigation project for the water system and a \$15.0 million overhaul of the wastewater treatment system because of the new NPDES requirements. Each of these major system improvement projects came at a cost to the community's residents and left no room in the capital replacement budget for basic line reconstruction.

Despite an LMI population of almost 75% and user rates that have jumped significantly to accommodate the debt repayments on the \$23 million+ bond issues, the community remains determined to construct all the components required to completely rehabilitate its water and wastewater systems. As an extension of the two large-scale projects, the City has worked to methodically replace deteriorated sewer pipes and install larger diameter water mains throughout the community. With bonding capacity maximized, the City has consistently put aside dollars each budget year to rebuild sections of the water and wastewater system, which are prioritized by deterioration and lack of capacity. This proposed project tackles Phase 4 of our system updates and targets the next in the series of critical line and pipe replacements.

The City is seeking \$454,800 from the Idaho Community Development Block Grant program to be matched by \$400,000 from the City budget and \$250,000 from the Buhl Urban Renewal Agency. Approximately 7,520 linear feet of wastewater and 6,640 linear feet of water line will be replaced, resolving issues with undersized water mains and deteriorating sewer pipes that have potential groundwater contamination. This project will also involve the replacement of related manholes, damaged streets, sidewalks and curbs and gutter, and the installation of additional fire hydrants to expand the City's fire protection capabilities.

The improvements that Buhl has made to its municipal infrastructure systems have laid the foundation for economic development and job creation. With the growing number of food processing facilities looking for homes in the Magic Valley, the water and wastewater system improvements that the City has completed establish the community as a favorable location.

With this next phase of construction, Buhl will be well on its way to putting in place water and sewer systems that can meet the community's needs into the next generation. The City has a long-term plan for these necessary improvements with an end goal in mind. The City's success has been and continues to be possible through our partnership with the Idaho Community Development Block Grant program.

F. Administrative Capacity

1. City of Buhl

The City of Buhl has a team with experience above and beyond what is necessary to complete this project. Mayor Tom McCauley has been with the City a total of 10 years and has the drive and forward thinking to ensure this project is a success. City Engineer Scott Bybee has been with the City for 19 years and has led the charge in the City's water and sewer system improvements. He has in-depth knowledge of the City's infrastructure

needs. Public Works Director Regie Finney has been with the City for 18 years, and manages the City parks, streets, wastewater, and water departments. City Clerk Karen Drown has been with the City for 8 years and is the go-to person for any City information.

2. Grant Administrative Services

The City has followed small purchase procedure to procure grant administration services. On September 24th, 2019, the City emailed a Request for Proposal packet to three certified grant administration consultants listed on the Idaho Department of Commerce website. Proposals were due back to the City by 5:00pm on October 7th, 2019. Region IV Development was the only firm to submit a proposal, and the City chose Region IV Development at their October 28, 2019 city council meeting. Grant administration procurement documents can be found in Exhibit 4.

G. Fair Housing

The City adopted a Fair Housing Resolution at their October 28, 2019 City Council meeting. A copy of the Resolution will be published prior to the submission of any addendum materials. Included in Exhibit 5 is a copy of the Fair Housing Resolution.

H. Anti-Displacement

By signing the Certifications associated with this application, the City of Buhl agrees to follow the State's Anti-Displacement and Relocation plan. No displacement is anticipated to result from the proposed project improvements.

Program Income

The proposed project is not anticipated to create any program income nor does the City have program income from a previous ICDBG project. Consequently, no program income reuse plan has been developed.

A. Project Description

Existing Situation

Over the last decade, the City has been working to improve sections of their wastewater and water line systems. The sections that have needed replacement have been identified through video inspection and engineering analysis. As infrastructure is reaching the end of its useful life, the City of Buhl has replaced critical sections as funds have accumulated in the City's capital reserve account. The City sets aside funds each year specifically for these replacements. This project addresses the next phase of these replacements.

Need

The failing sewer and water lines are a hazard to the health and safety of the community's residents. Engineering analysis and sewer line videotaping have identified deteriorated lines and failing sections of both sewer and water components. Additional information on the engineering assessment is included in Exhibit 6.

The City also has an LMI population of 74.85%. This high percentage makes it necessary to have updated and safe water and sewer systems that will improve the quality of life for our citizens.

Detailed scope of work

This proposed project involves the replacement of approximately 7,520 feet of old, undersized and damaged sewer line and replacement of approximately 6,640 feet of old and undersized water lines. This project will also involve the replacement of related manholes, damaged streets, sidewalks and curbs and gutters, and the installation of additional fire hydrants to expand the City's fire protection capabilities. The City of Buhl will be completely reconstructing one mile of Burley Avenue on the south side of town in 2022-24. Much of the work in this project will replace old infrastructure in the Burley Avenue right-of-way prior to the road project, so that the road will not need to be torn up to replace infrastructure at a later date.

Detailed information regarding the project components is included with the engineering assessment attached in Exhibit 6.

Outcomes and Benefits

This project has many potential benefits. As stated previously, this project is one in a long line that the City has scheduled to completely revamp the water and sewer systems. For City residents, and specifically the low-moderate income population, this project will provide reliable infrastructure, safe water and sewer systems, and reasonable rates over the long term. This project also builds a framework on which the City can expect to see economic and population growth. Updated infrastructure is a big factor when cities want to attract business. In an area that is heavily dependent on agriculture and food processing, Buhl will have a leg up in attracting business.

II. LMI Need and Impact

A. Low- and Moderate-Income Percentage Points

Based on the results of the income survey, City of Buhl has an LMI population percentage of 74.85%. Survey information is provided in Exhibit 1.

B. Need

The proposed project represents the solution to a "Critical Need".

As previously stated, the City of Buhl has many water and wastewater lines that are deteriorating and undersized. This poses a threat to the City, both from a safety and from an economic standpoint. It is well known that low-moderate income persons are vulnerable in both areas. The City has an LMI of nearly 75%, which means 75% of the City is especially vulnerable. It is necessary to have updated utility systems that improve the quality of life of citizens.

Additional information on the severity of the need is provided in the engineering assessment in Exhibit 6.

C. Impact

- 1. For the low-moderate income population, this project will provide reliable infrastructure, safe water and sewer systems, reasonable rates over the long term, and the ability to attract new businesses.

Since 2000, Scott L. Bybee, P.E. (an independent consultant) has been appointed as the City Engineer. An annual retainer is paid by the City to secure the day-to-day assistance and oversight for the community's infrastructure systems. When larger engineering projects are required, and the scope is viable for work by Mr. Bybee's firm, the City issues a separate agreement for the work and Mr. Bybee invoices the community for those engineering tasks outside the scope of his retainer contract. This system has saved the City a considerable amount of funds as opposed to calling in outside consultants for every engineering need. For larger projects that cannot be efficiently completed by Mr. Bybee, the City has used a formal RFQ process to procure those services.

2. Grant Administration

Region IV Development was selected as the City's grant administrator on October 28, 2019. Information on the procurement process is included in Exhibit 4.

LMI Survey Report

Per the most recent American Community Survey, the City of Buhl's LMI was 47.8%. Because they were so close to the 51% threshold to qualify for CDBG funding, it was decided to conduct an LMI survey of the City with the help of Region IV Development.

This was a random survey, and round 1 was done via mail. Since the City has a population over 4,000, it made more sense to post flyers alerting people of the survey, rather than mailing a letter to each household. The City sent Region IV an address list, and we at Region IV cleaned up this list, randomized it, and prepared the mailings for the City. After the flyer was posted and mailings were prepared, round 1 was mailed out by the City. Envelopes were made so that citizens would mail the surveys back to Region IV. Using the Survey Systems calculator, it was determined that the City needed a sample size of at least 319, and with 80% response this meant 256 valid responses were needed. Due to the size of the survey, it was decided to mail out 350 surveys rather than the minimum of 319 to help meet the response requirement. This mailing took place on September 24th, 2019. We received 132 valid responses to the mailing with an LMI of 60.2% for the first round. Our rate of return for round 1 was 37.7%. Once we started receiving only a couple responses per day, we got ready to knock on doors.

The City began round 2 knocking on doors on October 15th. The address list for round 2 was everyone who did not respond in round 1, as well as any replacements for vacancies and refusals. The door knocking was done by City employees Karen Drown, Teresa Robbins, Autumn Jones, AJ Gray, Jasmine Miles, and Rick Brook. In round 2 we received 134 more surveys, putting us over the minimum response requirement. This was completed on October 28th, 2019. The LMI for round 2 was 85.5%.

Each address had a random number assigned to it alphabetically by address. These numbers ranged from 1 to 1891. These numbers tie back into the randomization list found in this report. The addresses that were chosen to receive a survey through the randomization were also given a survey identification number (1-392) to simplify the tracking process. The final LMI numbers were **266 valid responses and an LMI of 74.89%.**

Within this document are the sample size calculator results, copy of the random numbers generated (also shows the replacements), maps of the survey and project benefit areas, LMI tabulation sheets, a copy of the original survey, and scans of all surveys that were received throughout the process.





Idaho Community Development Block Grant (CDBG) Citizen Participation Plan

City of Buhl

Pursuant to citizen participation requirements for Idaho Community Block Grant participants, the City of Buhl hereby certifies the following activities will be completed:

Provide for and encourage citizen participation, particularly for low and moderate income persons who reside in slum or blighted areas and areas in which CDBG funds are proposed to be used. Provide technical assistance to group's representative of low and moderate income persons that request assistance in developing proposals in accordance with procedures developed by the department. Such assistance need not include providing funds to such groups.

Hold a minimum of two public hearings, each at a different stage of the program, for the purpose of obtaining citizens' views. The first public hearing shall include a description of the proposed project, scope of work, budget, schedule, location, and beneficiaries. Any earned program income must also be noted. The application, related documents, and the Application Handbook shall be available for citizens to review.

The second public hearing on the status of funded activities and accomplishments to date; a general description of remaining work and a general description of changes made to the CDBG project scope of work, budget, schedule, location or beneficiaries.

A public hearing shall also be held in the event CDBG project activities are added, deleted or substantially changed from the application. Substantially changed means changes made in terms or purpose, scope, location or beneficiaries as defined by the CDBG program.

Provide reasonable and timely access to local meetings, information and records pertaining to the local government's proposed and actual use of CDBG funds. Public hearings shall be conducted at times and locations convenient to local citizens.

Public hearings shall be advertised in a local newspaper no less than seven (7) twenty-four (24) hour days prior to the hearing date. If there is no local newspaper, public notification will occur through some other method where there is wide distribution to citizens within the project area. The Community Development staff must approve this method.

A copy of the publication and/or affidavit of publication shall be submitted to the department. The notice should identify all of the topics to be addressed in the public hearing including the assurances that hearings shall be held in facilities that are accessible to persons with disabilities and that alternative formats shall be available to persons with disabilities where practicable, and with advance notice to the unit of local government.

Citizens shall also be notified they will be given the opportunity to comment orally or in writing at a minimum of seven (7) days prior to and at the hearing. Special accommodations shall be available for persons with disabilities who may wish to comment within this period.

Public hearings shall be conducted in a manner to meet the needs of non-English speaking residents where a significant number of non-English speaking residents can be expected to participate.

Local citizen participation records which shall be made available to the state and local citizens shall include: A copy of the public notice and/or affidavit of publication which describes proposed or actual project activities, scope of work, location, budget, schedule, objectives, and beneficiaries. Notices shall also contain the accessibility clause for persons with disabilities.

Grantees must provide the address, telephone number, and times for submitting complaints and grievances, and provide timely written answers to written complaints and grievances within fifteen (15) working days where practicable.

Local staff shall be familiar with citizen's complaint procedures. These procedures shall provide local citizens with the opportunity to protest project activities or related issues. A written complaint or grievance is formal notification of a concern, allegation or protest to a proper authority. A formal complaint will be considered filed at the time it is delivered to the appropriate authority's office. To file a complaint, citizens must provide enough information to allow an investigation. The complaint should be clear and concise and include the following information:

- A. Identification of the project, project location, and program activities.
- B. Reason for the complaint (hearsay and innuendo will not be considered valid).
- C. Sufficient data to substantiate any claims or charges. If possible, supporting documentation should be included.
- D. If desired, citizens may propose a solution to the problem.

If the complaint is concerning local activities or project implementation, complaints and grievances shall first be filed with the appropriate elected official. If this is the case, grantees shall be required to notify the department of the complaint. A copy of the response shall also be submitted to the department. Every attempt must be made to respond to citizens within fifteen (15) days where practicable.


If a citizen feels the response from the local jurisdiction is unsatisfactory, he or she may appeal to the department for resolution. The department at that time may request additional information. Every effort will be made by the department to provide a full response within thirty (30) days.

If valid and sufficient data has been provided to substantiate the complaint, an investigation will be conducted. The extent of an investigation depends on the scope and depth of the issues involved.

If the complaint is more appropriately directed toward the CDBG program activities, the same procedure will be followed except all communications are between the state and the complainant.



This proposed CDBG project involves the replacement of approximately 5000 feet of old, undersized and damaged sewer line and approximately 3000 feet of old and undersized water line along with replacing the related manholes, damaged streets, sidewalks and curb and gutter and the installation of additional fire hydrants to expand the City's fire protection capabilities. The City of Buhl will be completely redesigning and reconstructing one mile of Burley Avenue on the South side of town in 2022-2024 and much of the work this project is involved in will replace old infrastructure in the Burley Avenue Right-of-Way prior to the complete road reconstruction so the road does not need to be torn up in the future to replace the infrastructure at a later date. 

Region IV Development Association (RIVDA) appreciates the opportunity to present our qualifications in response to your request for assistance with the planning, development, grant writing, and administration of the W/WW project for which the City of Buhl is seeking Idaho Community Development Block Grant funds. We respectfully submit this information regarding our organization and the services we offer. Our response will address the areas of interest as outlined in your Request for Grant Administration Services Proposals.

Capability to Provide Assistance



Scott noted there were concerns with the work done on the previous grant. But those seem to have been resolved with new staff. The new application process has been going great with Keyan and Georgia. Michael moved to approve Region IV as grant administrator. Pam seconded the motion. Pam questioned the fee charged. Scott noted it is \$60,000 which is the same amount as the last grant but this is a bigger project. There was no further discussion and the motion passed.

Consideration of trash removal from Senior Citizens Center: Kelly Peterson, Senior Citizens Center Board member, brought to Council a concern of garbage being dumped and the Senior Center Thrift Store. He noted that the problem has gotten worse since the closing of the Youth Ranch. He added the board has discussed ways to alleviate the situation. They are planning on installing a gate and posting that donations are only accepted during business hours. Kelly came to Council to ask if the police could patrol that area and watch for those that might be dumping. The other request was that hauling the items to the transfer station is a problem sometimes, he was wondering if the adopt-a-truck would be available and if the city would be willing to waive the fee for use of the truck. Karen informed Council and Kelly of additional information. In 2018 the Twin Falls County Commissioners considered the reduced charges for similar thrift store business to dump at the transfer station. Mayor McCauley noted the possibly writing them a letter for a similar requested could help with the fees to haul off the items. There was further discussion of concerns and also the amount of business that is done through the thrift store. Kelly noted some items that are received are forwarded on to ARC and the Valley House. Michael stated he understood because his church had a drop off site for awhile and it too received items that should have gone to the dump. Michael moved to waive the adopt-a-truck fee for trash removal at the Senior Citizens Center Thrift Store. Pam seconded the motion. There was no further discussion and the motion passed.

Consideration of Bank Account Signatures: Karen explained that new federal regulations require and Council approves signers for all bank accounts and any changes to those. The proposed list would add Michael Higbee to those accounts. Michael moved to approve the bank account list: Tom McCauley

COUNCIL CONCERNS – Kyle asked that Fire Truck 101 be taken and stores somewhere else. Regie noted that 101 is still used and he is working with Chief Stevens on room at other locations to park some equipment.

Resolution No. 404

RESOLUTION OF THE CITY OF BUHL DECLARING APRIL 2020 TO BE FAIR HOUSING MONTH IN THE CITY OF BUHL AND AFFIRMING THE CITY'S COMMITMENT TO FAIR HOUSING POLICIES AS HEREIN PROVIDED.

WHEREAS, The City of Buhl, Idaho desires to let it be known to all persons of the City of Buhl that discrimination on the basis of race, color, familial status, religion, gender or national origin in the sale, rental, leasing or financing of housing or land to be used for construction of housing or in the provision of brokerage services is prohibited by Title VIII of the 1968 Civil Rights Act (Federal Fair Housing Law); and

WHEREAS, It is the policy of the City of Buhl to encourage equal opportunity in housing for all persons regardless of race, color, familial status, religion, gender or national origin. The Fair Housing Amendments Act of 1988 expands coverage to include disabled persons and families with children. Therefore, the City does hereby pass the following Resolution.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR OF THE CITY OF BUHL AS FOLLOWS:

Section 1: Within available resources the City will assist all persons who feel they have been discriminated against because of race, color, religion, gender, national origin, disability or familial status to seek equity under federal and state laws by referring them to the U.S. Department of Housing and Urban Development, Office of Fair Housing and Equal Opportunity, Compliance Division.

Section 2: The City shall publicize this Resolution and through this publicity shall encourage owners of real estate, developers, and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law and amendments and any applicable state or local laws or ordinances.

Section 3: SAID PROGRAM will at a minimum include: 1) publicizing this resolution; 2) posting applicable fair housing information in prominent public areas; 3) providing fair housing information to the public; 4) preparing a fair housing impediments analysis; and 5) declaring April as Fair Housing Month.

CITY OF BUHL 2019-2020 SEWER AND WATER LINE REPLACEMENT PROJECT

SEWER COMPONENT PROJECT DESCRIPTION:

The City of Buhl owns and operates a wastewater collection and treatment system that serves the area in and around the City. In addition to new Federal and State standards for discharge to the Snake River that required upgrades to the wastewater system, the City has experienced steady residential, commercial, and industrial growth that is exerting an increasing demand on the wastewater collection and treatment systems. It is anticipated that this growth will continue in the future. In 2013 the City of Buhl completed a \$13 million dollar wastewater treatment Facility upgrade which brought the facility into compliance with IDEO and EPA 2013 standards and increased capacity for future growth. However, the treatment project diverted funds and funding that the City had targeted for replacement of very old, deteriorated collection lines that have been identified by the City as already failed or facing imminent failure. In the late 1990's, the City began a comprehensive analysis of the collection system to determine which lines were in need of replacement and in what time frame. This analysis was conducted as part of a facility plan update and included the videotaping of 96% of the sewer lines in Buhl at the time. Since then, 100% of the lines have been videotaped at least once and many have been videotaped additional times to assess the progress of the damage. The City now requires that all new sewer lines also be videotaped prior to acceptance by the City. The analysis prioritized the replacement of the lines and the City embarked on a strategy to begin the replacement. The deteriorated lines were allowing wastewater to seep out of the lines in areas of no groundwater and were allowing groundwater to seep into the lines in areas of high groundwater. Both of these situations are unacceptable and present health and safety issues to the community and increase the flow to the wastewater facility in the high groundwater seasons of the year. All of the deteriorated sewer lines were included in the City's 2006 updated Facility Study conducted by JUB Engineers, Inc. The City is very concerned about the ability of the existing wastewater treatment collection infrastructure to remain in compliance with Idaho Department of Environmental Quality (IDEQ) and the US Environmental Protection Agency (EPA) regulations. As a result of the City's deteriorated collection lines, the City could be found to be out of compliance and could be fined by the EPA for non-compliance with their National Pollutant Discharge Elimination System (NPDES) permit.

The sewer pipeline condition study found that 62.05% of the City's total collection system is failing. This represents 66,824 feet of pipe of the total of 107,702 feet of pipe within the City. At an approximate replacement cost of \$110 per foot of pipe, the cost to replace the failed portions of the collection system total nearly \$7,400,000. The major contributing factors to the failure of the collection system are simply the age of the pipe and the type of pipe.

Predominantly the pipe is in excess of 75 years of age and made of concrete which fails due to harmful hydrogen sulfide gas faster than pipes constructed of newer PVC and HDPE materials. Since the late 1990's, the City has systematically identified the worst of the lines and attempted to address the replacement as funds became available. Every year the City budgets money to replace sewer lines but unfortunately they are failing at a faster rate than the City can budget. This is primarily due to the fact that the required new wastewater treatment facility used all of the City's bonding capacity for completion of that project in 2013. The City's current wastewater monthly fee is in excess of \$70 which is among the highest in Idaho. This includes the bond repayment for the 2013 project. Of this total \$4.50 is specifically itemized within the budget for sewer line replacement and other capital replacement needs. This generates approximately \$90,000 per year to the sewer line replacement fund. In addition to this \$90,000 the City budgets money each year for continued maintenance and videotaping of the sewer lines. The City's best option is to continue to collect these funds and use them to try to leverage other grant or low interest loans in an effort to expand the replacement project each time to do more pipeline replacement. The City has been successful with this strategy in the past and will continue as City funds and other funds become available. In 2012, the City did \$2,189,820 worth of replacement lines that included replacing the City's old siphon carrying flow to the wastewater treatment facility with a gravity sewer line. This project was a combined effort of City funds and United States Corp of Engineers funds.

In 2014-15 and again in 2016-2017 the City of Buhl replaced deteriorated sewer pipe at a total cost of nearly \$2,000,000. These City / URA / ICDBG Projects were Phase III and Phase IV of the comprehensive strategy to upgrade the City's wastewater treatment and collection system to new EPA standards and get 48% of the failed pipes completed in a five year window of opportunity. While there is still a lot to do, these projects address the most serious conditions and the City intends to continue to address the pipe failures until all 66,824 feet of pipe are replaced over the next 10 to 20 years. The proposed 2019-20 City / URA / ICDBG Project will be Phase V of this effort and will address an additional 7520 linear feet of deteriorated sewer line which represents another 11% of the total pipe needing replaced.

Approval of the wastewater treatment bond and increases to the budget earmarked for pipeline replacement have raised the wastewater user rates by 308% per month (\$16.49 to \$67.27 monthly) which is an extreme burden on the single head of household and elderly residents of Buhl. The user rates were initially determined, reviewed, approved and increased by the Buhl City Council over a five year period in order to bring the rates from where they were to where they needed to be but do it over a period of time to soften the burden imposed on the City's users. The rates were also reviewed and approved by the Idaho Bond Bank during the bonding phase. In addition, fourteen public meetings were conducted over the five year period to assure the rates were appropriate for the City of Buhl. The Buhl sewer rates were most recently

reviewed and increased in September / October of 2019. As a result a 1.3% increase took place in October of 2019.

The proposed 2019-20 project includes the following improvements:

- 1) Replacement of deteriorated sewer lines in the northwest and southeast portions of the community which are predominantly LMI households with very old sewer mains.
- 2) Replacement of deteriorated sewer lines in the Burley Avenue portion of the community. Burley Avenue is scheduled for total reconstruction in 2023/24 and the City wants to replace these aged pipes prior to the total road reconstruction.

Less than 15% of the total project will impact non-residential areas. Conversely, 85% of the project will replace sewer lines in the residential areas of Buhl. During a door to door survey conducted in the fall of 2019, Buhl was found to have 74.85% LMI households.

Because all of the existing and proposed sewer lines are either within designated City right-of-ways or within existing easements, 100% of the project components will be constructed in areas of City control. Almost all of the proposed piping will be replacement of existing sewer lines with the exception of a short extension on Burley Avenue which is in an existing right-of-way and within previously disturbed ground. No new ground will be disturbed as the replacement lines will be installed in the same location and same depth as before. No new property, easements or right-of-way will be required. The City intends to design more replacement sewer lines than can be expected to be replaced by this project so that the project can be expanded immediately should lower than expected bids be received. A thorough environmental analysis and review for the project was completed during the facility study phase for potential IDEQ funding. The only additional environmental review required will be a review to assure that all Idaho Department of Commerce requirements are met. The project complies with the existing zoning requirements of the City of Buhl.

The proposed design is based on replacing the deteriorated concrete sewer lines with PVC and HDPE sewer pipe which has a much longer life span than the existing concrete lines. With appropriate maintenance the new lines should function well for sixty to eighty years. The City already follows state standards for maintenance of the sewer lines by routinely cleaning the lines, removing tree roots that penetrate through the service lines and by televising the lines on a five year cycle to determine problem areas.

With the completion of this project, the City's wastewater treatment facility will continue to see lower hydraulic loading because groundwater seeping into the existing broken pipes will be decreased. This will be an important benefit to the community as the available capacity for additional residential, commercial and industrial growth is increased. Further, wastewater

leakage from the pipes will be decreased providing a safer environment for the community health.

With the City's completion of the new wastewater treatment facility in 2013 at a cost of \$15,000,000 and completion of the City's new water treatment facility in 2012 at a cost of \$8,000,000, the sewer line replacements are now the most critical need of the community in regard to existing infrastructure and the potential for future IDEQ and / or EPA non-compliance.

Without these necessary improvements, the City of Buhl could be subjected to fines of up to \$37,500 per day per violation if the lines continue to deteriorate to the point where IDEQ and EPA compliance is in question. Once the magnitude of the problem was quantified, the City has not delayed their efforts to stay in compliance but is simply faced with a huge financial burden that will take many years to adequately address.

WATER COMPONENT PROJECT DESCRIPTION:

The City of Buhl's Water Treatment Facility is located on Clear Lakes Road approximately 600 feet north of Highway 30. At this site, various flows of water from an onsite well as well as other City wells are pumped through a series of water storage reservoirs, filters and treatment components which effectively reduces the amount of Arsenic in the water so that the end product is below the EPA mandated 10 parts per billion (ppb). The facility has been in operation for the last nine years and has resulted in full compliance with the new mandated EPA standards. All City water is treated including irrigation water delivered through the potable water distribution system, commercial and industrial water and residential water. The system operates between 30% and 55% of capacity depending on the time of year and water demand. The system is a state of the art treatment system that will provide service to the City of Buhl over the next 30 to 50 years. In addition to the water treatment facility, the City owns and operates four deep well pumping systems that pump water from the underlying aquifer to the distribution system and water treatment facility. The wells are capable of pumping up to 5000 gallons per minute (gpm) to the storage reservoirs and the distribution system during peak demand.

In 2005, the Environmental Protection Agency (EPA) modified the allowable Arsenic level in municipal drinking water from 50 parts per billion (ppb) to 10 ppb based on their scientific research. This was done to protect users from possible harmful effects of high concentrations of Arsenic in drinking water. A Facility Plan was conducted that helped define the project alternatives and provide cost estimates. The final cost of the improvements was \$8,000,000. This amount was passed by the voters of Buhl on August 1, 2006. Construction began in October of 2008 and all work was completed in the spring of 2010. Sale of the voter approved

bond issue was October 8, 2008. Prior to this date the City Council passed the final step to increase in the user rates to be able to repay the \$8,000,000 in bonds over a thirty year period. The City currently has around 1820 connections that represent approximately 2511 equivalent residential users.

As with the sewer system, the diversion of funds that were collected over the years for water line replacement to the mandated water treatment facility left the City of Buhl with very few resources to continue their strategy of replacing older, undersized water mains with larger PVC water lines that would provide higher fire flows and higher system pressure. In addition, the City's replacement strategy also removed the Arsenic laden deposits on the interior of the older water lines (which cannot be removed without full pipeline replacement) by replacing the water lines. Many of the City water mains are still 4" and 6" pipes which are being replaced with 8", 10" and 12" water mains.

The total water bill for residents of Buhl starts at around \$45.00 and increases from there depending on actual monthly water use. This billing includes two existing Water Bond repayments and a capital improvement payment to collect funds for water line replacement.


THE TOTAL UTILITY BILL FOR BUHL RESIDENTS IS OVER \$140 EACH MONTH because of the EPA mandated water and wastewater projects that totaled \$23,000,000.

The proposed 2019-20 project includes the following water system improvements:

Replacement of 6640 linear feet of deteriorated and undersized water lines in the southeast and east portions of the community which are predominantly LMI households with very old water mains. The plan is to replace an existing 2' and 4" water mains with new 8" water mains which will quadruple the potential fire flow, increase water pressure to the elderly housing complex and LMI residents and reduce the Arsenic levels in the vicinity of the users by eliminating the older, undersized pipeline.

Because all of the existing water lines are either within designated City right-of-ways or within existing easements, 100% of the project components will be constructed in areas of City control. All of the proposed piping will be replacement of existing water lines. No new property, easements or right-of-way will be required. A thorough environmental analysis and review for the project was completed during the facility study phase for potential IDEQ funding. The only additional environmental review required will be a review to assure that all Idaho Department of Commerce requirements are met. The project complies with the existing zoning requirements of the City of Buhl.

The proposed design is based on replacing the deteriorated cast iron and steel water lines with PVC water pipe which has a much longer life span than the existing lines. With appropriate maintenance the new lines should function well for sixty to eighty years. The City already follows state standards for maintenance of the water lines.




CITY OF BUHL SEWER LINE VIDEPTAPING SUMMARY

DESCRIPTION:

Since the mid 1990's, the City of Buhl has been videotaping their sewer lines to develop a strategy to determine the condition of the existing sewer lines, an appropriate replacement schedule and the approximate costs of such an endeavor. The City has 107,702 feet of pipe (20.4 miles) that serves the community. Over the last 15 years, 100% of the lines have been videotaped with many lines being videotaped several times to determine the speed of the deterioration of the older pipes. The City's sewer collection system is predominantly very old concrete pipe that degrades more rapidly than newer PVC pipes. Since 1995, the City of Buhl has expended nearly \$235,000 cleaning and videotaping the sewer lines in this effort.

Attached is a typical report from the videotaping and some pictures of the existing conditions of the sewer lines along with some pictures of the lines after replacement. Also attached is an index of the lines in Buhl that have been videotaped. The indexing refers to the grid location of the beginning and ending manhole of each pipe section.

The City of Buhl will be submitting design plans to the Idaho Department of Environmental Quality (IDEQ) late in the week of November 18, 2019. The plans represent the proposed work for the City of Buhl's 2019-2020 ICDBG Sewer and Water Project. The City of Buhl Engineering staff has been preparing the plans since August 2019 when the City and the Buhl Urban Renewal Agency decided to pursue an ICDBG application. Based on past submissions and reviews, the City of Buhl anticipates that IDEQ will respond back to the City sometime between the middle of December and the middle of January of 2020. Certainly, the City expects to have review comments back from IDEQ well in advance of the addendum request by the Idaho Department of Commerce, should the City of Buhl be fortunate enough to be invited back for final applications. Approximately 95% of the work involves replacing EXISTING old and undersized sewer and water lines in Buhl. All of the work will be within existing City rights-of-way and utility easements in the City's control. The remaining 5% of the work will be to add an extension to a sewer line in Burley Avenue before the roadway is totally reconstructed in 2023/24.

By submitting the plans to IDEQ now for review and approval, the City believes it can get a jump on bidding the work earlier in 2020 than if the plans were completed after potential ICDBG approval. Over the last few years we have experienced a smaller and smaller contingent of qualified contractors that do this type of utility line replacement in southern Idaho. This was evidenced by our last project in 2016-2017 as we struggled to keep our bidder on site as they had more work than they could reasonably handle. We only received two bids for that project, and we recognize that we will perhaps have to seek other capable contractors further away in the

future. Bidding the work early in the construction season will only help in this overall effort and will allow us to stay within budget and within our proposed schedule. Because the City has bid the previous projects with flexibility in the design and award phases of the project, the City has completed all the previous projects under budget.

All the sewer and water lines being installed as part of this project are priority replacement lines as determined by previous Facility Studies on the sewer and water systems in Buhl. Further, all the design work will comply with the most current requirements of the Idaho Department of Commerce, Davis-Bacon wage requirements and IDEQ.



Good afternoon Keyan. This email responds to your October 24, 2019, letter to NOAA Fisheries requesting comments on the Buhl Water and Wastewater Project. NOAA appreciates your efforts to address environmental issues in the Snake River basin. Based upon my review of the letter, the project area described is located upstream of Hells Canyon Dam on the Snake River. NOAA Fisheries considers the Hells Canyon Dam a longstanding, naturally impassable barrier. Consequently, there are no Endangered Species Act (ESA) listed species under NOAA's jurisdiction occurring in the vicinity of this project area. Similarly, there is no designated critical habitat for any ESA-listed species under NOAA's jurisdiction in this project area. Therefore, although NOAA Fisheries appreciates the notification regarding your project and a chance to provide input, NOAA will not be providing additional comments on your proposed action, and no ESA consultation or further coordination with NOAA is necessary before completing your action.
