Call to Order

Chairman Rep. John Vander Woude called the meeting to order at 1:00pm with a quorum present.

Roll Call

Approval of Minutes

Chairman Vander Woude noted that the minutes for June 2, 2021, Idaho Broadband Advisory Board meeting had been distributed.

Motion:

If there are no corrections, move to approve the minutes as distributed.

Board Purpose and Procedures

In regard to the purpose and structure for the group, Representative Blanksma presented to the Idaho Broadband Advisory Board the Water Board bylaws.

The Advisory Board discussed the similarities and differences between the water board organization and those of the Economic Advisory Council (EAC) whether either structure better fit the Advisory Board.

There were no concerns about the draft provided by Representative Blanksma.

For Idaho Department of Commerce to make a draft proposal about the board structure and bring it to the board for final approval.

CARES Act Funding of \$10 Million- Process and Time Frame

Concerns about the grant only targeting households but not the middle mile or other types of projects. It was mentioned that the guidance for the use of the CARES funds must meet certain criteria such as for people to telework, have access to telehealth, and for online learning. Therefore, new wording for the grant portal must make sure to include CARES criteria.

Board members discussed the wording on the grant portal for the public comments. Board members mentioned that it is preferred to have a wide definition of those who can apply to expand the pool of applicants.

Board members also discussed the possibility to add wording so applicants know that if they don't qualify for \$10 million it can be considered for additional funding.

As of the time of the meeting, Idaho Commerce has not received any public comments.

Motion:

For Idaho Commerce to remove household designation and to rewrite the guidelines to broaden eligible applicants. Also, to mention that if the project is not funded with the 10 million, the project is not excluded from being funded by the 35 million.

All in favor. Motion passed.

New Business

Senator Nelson gave a brief overview of the challenges and accomplishments of the Idaho Broadband Task Force. He mentioned that the Task Force:

- identified where challenges in the state were.
- included recommendations on dig once and hang once.
- need to address middle mile projects and public safety projects.

The task force provided recommendations to Governor Little in 2019. Idaho Commerce will provide the recommendations given to Governor Little by the Task to the Advisory Board.

Another discussion was what broadband plans look like in other states. Idaho Commerce mentioned that they will provide the Board with an interactive website link that compares states, contains executive summaries and overviews on broadband plans.
