**Zach Tudor, Associate Laboratory Director, Idaho National Laboratory and National and Homeland Security**

Zach Tudor is the Associate Laboratory Director of Idaho National Laboratory's National and Homeland Security (N&HS) directorate.

INL's N&HS is a major center for national security technology development and demonstration, employing 550 scientists and engineers across \$300 million in programs. N&HS is responsible for INL's Nuclear Nonproliferation, Critical Infrastructure Protection, Defense Systems and Homeland Security missions.

These missions include safeguarding and securing vulnerable nuclear material, enhancing the overall security and resilience of the nation's infrastructure, and providing protective system solutions and heavy manufacturing of armor for national defense. N&HS supports major programs for the Department of Defense (DOD), Department of Homeland Security (DHS) and the Intelligence Community.

A retired U.S. Navy Submarine Limited Duty Electronics Officer and Chief Data Systems Technician, Tudor holds a master's degree in Information Systems concentrating in Cybersecurity from George Mason University, where he also was an adjunct professor teaching graduate courses in Information Security. His professional credentials include the Certified Information Systems Security Professional (CISSP), Certified Information Security Manager and Certified Computer Professional.



**Tom Kealey, Director, Idaho Department of Commerce**

Tom Kealey is the Director of Idaho Commerce. Director Kealey is responsible for leading the state's economic development efforts, fostering a business-friendly environment to aid in job creation, supporting existing companies, strengthening communities and marketing Idaho domestically and abroad.

Director Kealey received his master's degree from Harvard Business School and a bachelor's degree from the University of Washington. He has held numerous senior business roles in Fortune 500 companies and is a long-time Idaho business owner and investor. Director Kealey was appointed by Governor Brad Little in January 2019.
