One application, while its focus is disruptive and intriguing, its scope was too expansive and time for completion was unrealistic; one application was submitted from an early stage company; the focus of another project was the development of what appeared to be an "add on" feature; one project while interesting in nature did not recognize the reality on how industry incrementally acquires technology; and the focus of the last application was a new product, however it was unknown as to why the industry partner, who is a global conglomerate didn't fund the research project itself.
