Idaho Office Broadband Update

Meeting Minutes Summary:

Ramón Hobdey-Sánchez from the Idaho Department of Commerce provided an update on Idaho Broadband. Key points discussed in the meeting include:

Idaho CPF Grant Discussion & Funding Decisions

Hobdey-Sánchez reported on the evaluation process for broadband projects:

- Reviewed 105 projects submitted by 37 applicants.
- Used three teams of three subject matter experts to grade each application.
- Each application was reviewed by three individuals.
- Some applications were scored out of 190, and others out of 210 due to a need to give them equal consideration.
- -The board discussed scoring and bonus points and adjusted the top scorers for award. All motions determined to be pending adjudication and recheck of formulas and funding.
