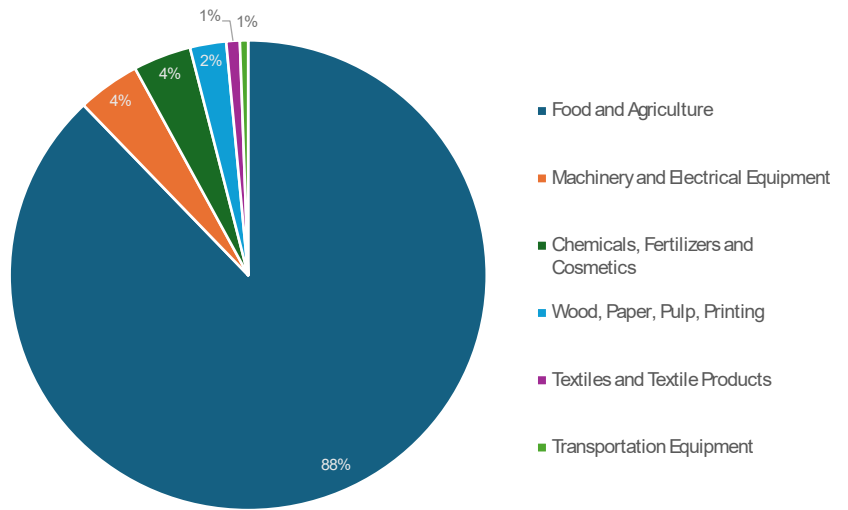




2023 Idaho-Mexico Trade

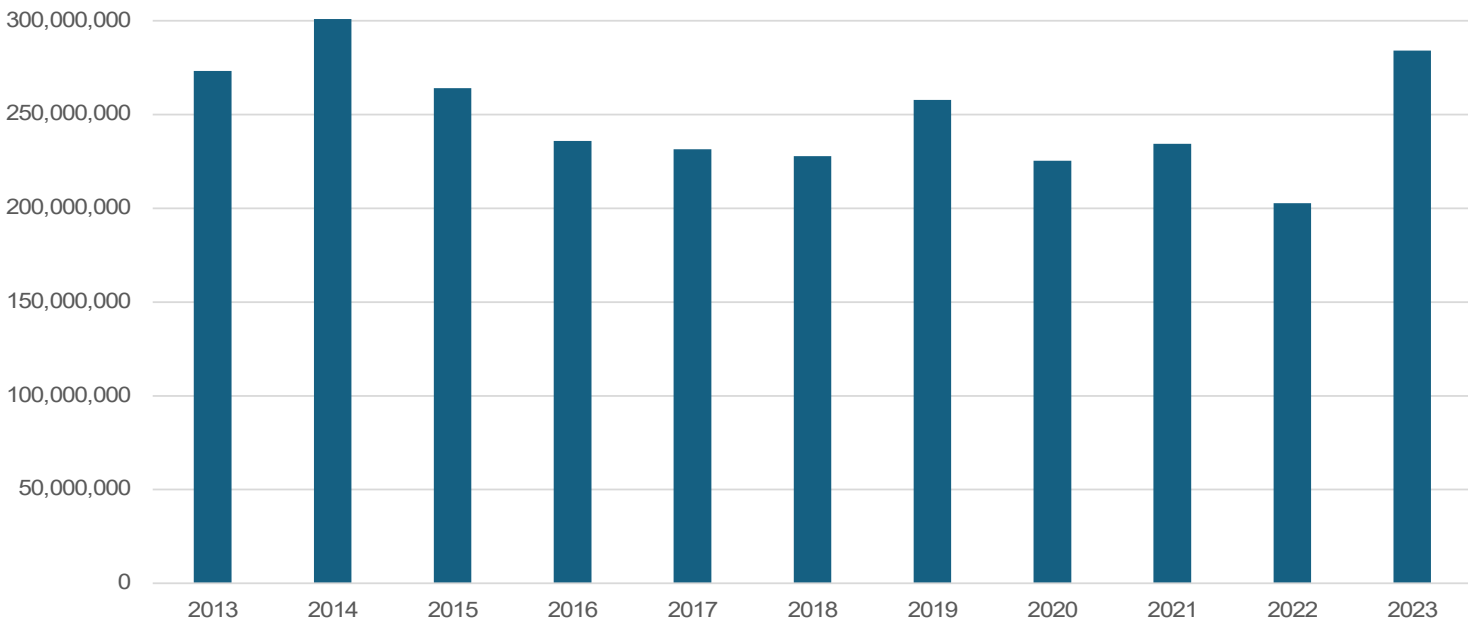
TOP EXPORT INDUSTRY OVERVIEW

- Mexico is Idaho's third largest export partner.
- Exports to Mexico totaled over \$284 million in 2023. This is an increase of 40% from last year.
- Food and agriculture remains Idaho's leading export category to Mexico, accounting for 88% of all exports.
- Machinery and electrical equipment exports grew by 65% last year.
- Imports to Mexico increased by 2% from last year.
